Rules & Regulations

I hereby apply as an entrant in the Miss St. George Program, and I acknowledge and agree as follows:

1. I have been a resident of St. George for six (6) months prior to the Miss St. George event, and I am a resident of St. George and plan to be during my entire reign, and I am a female citizen of the United States of America.
2. I am single, have never been married nor had a marriage annulled, never cohabited with a male in lieu of a marriage contract, and I am not nor have ever been pregnant.
3. I shall be at least fifteen (15) years old and under eighteen (18) years of age as of September 1, 2024, and currently a sophomore or junior in high school in the Washington County School District.
4. I shall submit a certified transcript to verify my GPA is 3.25 or above.
5. I am of good moral character, and I have never been convicted of any crimes. I shall not be dishonest, immoral, immodest, or indecent. I shall present at all times friendliness, helpfulness, a pleasurable disposition, and my words and actions shall be above reproach. Any un-lady like conduct or poor sportsmanship on behalf of a participant/title holder or parent/guardian shall be grounds for permanent disqualification. Emphasis shall be placed on the participants/title holders and adults displaying good manners and grooming, listening to and acknowledging instructions, adjusting to conditions, maintaining discipline, dependability and responsibility and above all, displaying **excellent sportsmanship** at all times. Any participant/title holders, parents/guardians, groomers, teachers, guests who conduct themselves to the contrary either before, during or after an event, shall be subject to immediate dismissal from The Miss St. George system. Such conduct deemed inappropriate by the program directors on the part of the title holders and their parents/guardians shall mean automatic forfeiture of their titles, scholarships and all rights thereof.
6. No smoking, alcoholic beverages or mind altering drugs shall be allowed in or around a program event. This rule is strictly enforced throughout the program year and includes participants/title holders, parents/guardians, staff and guests. Violations of this rule shall mean immediate disqualification from the Miss St. George system.

7. Family members, guardians, teachers, groomers, visitors and guests shall not visit the participants dressing rooms, restrooms nor be allowed backstage during the Miss St. George event. If found in violation, the contestant will be subject to disqualification.

8. I shall display a talent of 2 minutes maximum. Should I exceed the maximum time limit, my talent shall be disqualified and shall not be counted in the total points! Talent must be presented live and not by way of video or film. Any music must be submitted to pageant directors no later than May 31, 2024 via email or thumb drive which has been cued/labeled with contestant number and track number. No live accompaniment or sheet music allowed.

9. I shall perform a minimum of 10 hours of community service for the organization or charity of my choice.

10. I shall not have any other obligations that shall prevent me from participating and appearing as requested or required. As part of the title holders, I shall participate in all mandatory appearances and activities as assigned by the City of St. George and/or Program Director. The Washington County Fair assignments are mandatory!! Failure to assume these assignments shall result in removal from my position and relinquishment of all titles, crowns, awards, prizes, gifts, etc. Furthermore, as a contestant, I acknowledge that I am applying for a position to represent the City of St. George, and if chosen I agree not to participate in any other pageant systems during my reign as Miss St. George or Royalty attendant. If it is discovered that I have competed in another pageant, I will be stripped of my title and forfeit all scholarship monies associated with said title.

11. Title Holders shall not release any publicity through their own efforts. All public releases are to emanate through or have the approval of the City of St. George and /or Program Director

12. A princess shall not win a crown title more than once. All decisions and elections by the Judges are final! All participants/title holders, parents/guardians, family members, teachers, groomers, visitors or guests shall not approach the auditors/judges at any time, before during or after the program! Any infraction of this rule shall result in forfeiture to the participant/title holder.

We have read and completely understand the above and agree to abide by the same as a condition of my participation or title. Should we not be able to abide by the above, we shall be disqualified from participating in the Miss St. George Scholarship Program.
